Low viscosity epoxy resin modified by non-toxic reactive thinner

1. Product characteristics

BETOLIT EP 0-1 DC is a specially formulated low-viscous and low-molecular epoxy resin. Meets the requirements of EN 13813.

supplied in a specified ratio of each component; no measuring in-situ required after hardening shows perfect mechanical properties

after hardening is permanently resistant to effects of aggressive acidic and alkaline medias, oils, oil products, etc.

2. Use

BETOLIT EP 0-1 DC is an epoxy composition on the basis of specially formulated epoxy resin, which is intended especially for highly mechanically and chemically resistant floor finishes. Besides, it is used as connecting (adhesive) bridge under spread and film coatings made of epoxy polymer mortars and concretes. It is also intended for pressure (forced) injection of cracks in concrete and reinforced concrete structures.

Due to its high resistance resin **BETOLIT EP 0-1 DC** meets requirements for protection of railway bridges to stray currents.

5. Instruction for preparation and application

Use of the epoxy resin should generally proceed according to the specific technological processes of BETOSAN s.r.o. company. (see below)

The composition is prepared by proper mixing of components A and B in specified ratio. The mixing ratio is the following:

Components A and B shall be well mixed in a vessel of sufficient size by an electric driven slow speed propeller agitator.

6. Application

Application should generally proceed according to the specific technological processes of BETOSAN s.r.o. company. For example technological processes for making adhesion joint (TP 6/00/06), for making a grouting composition (TP 8/00/06), for application of polymer-mortars and polymer-concrete (TP 10/00/06), for application of polymer-mortars and polymer-concrete with color surface finalization Quarzcolor (TP 11/00/06) and for impregnation and over-laying of silicate surfaces (TP 16/00/06).

7. Packing and storage

BETOLIT EP 0-1 DC component A is supplied in cans of 6 kg or 2 kg, component B is supplied in cans of 3 kg or 1 kg.

The shelf life of the product in original undamaged packing is 24 months. During storing and transportation take into account that it's a flammable material of a IV. Class.

8. Health protection at work

Work with a two-component system **BETOLIT EP 0-1 DC** requires adequate sanitary measures usual for work with materials on the epoxy basis. First of all it is necessary to follow relevant provisions of Czech Standards SN 64 1301 and SN 65 0201. The workplace shall be properly ventilated, workers shall have adequate personal protective equipment, and no eating, drinking or smoking is allowed while working.

In case of eye contamination it is necessary to rinse out eyes with clean water and immediately seek out medical aid. In case of accidental swallowing it is necessary to immediately cause vomiting and immediately seek out medical aid. In case of afflicted skin it is necessary to wash thoroughly the irritated skin with warm water and soap and treat it by a suitable reparative cream.

BETOLIT EP 0-1 DC is a flammable material of the IV. Class.
