

BETOLIT PU 1C fix

Solvent-free polyurethane injection resin

1. Product characteristics

BETOLIT PU 1C fix is a specially formulated low-viscous polyurethane resin. Meets the requirements of EN 1504-5.

- expands its starting volume up to 2000% after mixing
- very low viscosity
- very fast hardening

2. Use

BETOLIT PU 1C fix is a solvent-free, polyurethane injection resin for temporary sealing of leaking cracks in concrete and masonry structures. Reaction with water yields a rigid, slightly flexible polyure-thane foam. For permanent sealing of leaking cracks, it is necessary to subsequently **BETOLIT PU 2C elastic** polyurethane injection resin. To be injected with a single-component injection pump.

4. Test certificates

5. Instruction for preparation and application

Application procedure is in detail specified in the internal technological procedure BETOSAN No.30/12 "TP for cracks injection with **BETOLIT PU** polyurethane resin.

<u>The composition is prepared</u> by proper mixing of component A (PU resin) and B (catalyst) in a specified ratio. Shake the component B (catalyst) well before adding it to the mixture. Mix component A (PU resin) and B (catalyst) in a ratio from 6 to 10% to achieve a required reaction time (see Table below). For injection use packers and a single-component injection pump. The mixing ratio is the following:

Neither <u>temperature of base</u> nor temperature of ambient air shall be below + 10 $^{\circ}$ C and above + 30 $^{\circ}$ C.

Injection pump and other tools can be cleaned with BETOSAN PURCLEAN agent.

6. Specific consumption

Specific consumption of **BETOLIT PU 1C fix** depends on the width of the cracks to be filled.

7. Packing and storage

BETOLIT PU 1C fix component A is supplied in metal canisters of 25 kg or 10 kg, component B is supplied in cans of 2.5 kg or 1 kg (10% of component A). Shelf life of the product in original undamaged packing is 12 months. The material must be stored protected from moister and at temperatures between +10 $^{\circ}$ C and +30 $^{\circ}$ C. Once opened packing must be for further use well sealed or preferably covered with nitrogen.

During manipulation and storage keep in mind that it is a flammable material of Class IV.

8. Health protection at work

Work with a two-component system **BETOLIT PU 1C fix** requires adequate sanitary measures usual for work with materials on the polyurethane basis. First of all it is necessary to follow relevant provisions of Czech Standard SN 65 0201. The workplace shall be properly ventilated, workers shall have adequate personal protective equipment, and no eating, drinking or smoking is allowed while working. In case of eye contamination it is necessary to rinse out eyes with clean water and immediately seek out medical aid.

In case of accidental swallowing it is necessary to immediately cause vomiting and immediately seek out medical aid.

In case of afflicted skin it is necessary to wash thoroughly the irritated skin with warm water and soap and treat it by a suitable reparative cream.

BETOLIT PU 1C fix is a flammable material of Class IV.
